 - b. The staircase treads and flooring shall be treated with rough finish (grooving) to avoid falling of children.
 - c. As per Para 6.3 of the BIS standards IS 14435 : 1997 as the classrooms have only one entrance, the capacity of the classrooms shall have to be limited to 45 students.
 - d. Periodical maintenance and care should be taken to maintain all fire protection equipments.
